Dear Mr. Dickerson,

It has come to my attention that you, Terry Maurice Dickerson, Member No. 1160, have committed serious Masonic Crimes.

1. You have violated the Constitution of the Most Worshipful Prince Hall Grand Lodge of TN along with the Oath and Obligations of our order by having Masonic intercourse with a body of Freemasons that does not have Masonic Recognition from the Most Worshipful Prince Hall Grand Lodge of TN.
2. You have violated the Constitution of the Most Worshipful Prince Hall Grand Lodge of TN by your willful violation of the demit process of this Grand Lodge. You did willfully join another body of Freemasonry with full knowledge that you were a suspended Freemason in this jurisdiction. You are currently awaiting your masonic trial for Unmasonic conduct and are not a member in good standing, yet you petitioned another body of Freemasons without holding a valid demit.

I, L. Lamont Banks, the Grand Master of Prince Hall Masons, for the State of Tennessee, hereby expel you, Terry Maurice Dickerson, from The Most Worshipful Prince Hall Grand Lodge of TN.
